Mary was defense counsel in the Stand n' Seal Spray-On Grout Sealer multi-district litigation where she handled all aspects of litigation and trial including traveling the country taking the depositions of over 190 plaintiffs and other witnesses. Following the resolution of all the cases, she assisted in obtaining a \$30 million arbitration allowing her client to recover its attorneys' fees, expenses and settlement amounts paid during the course of the underlying litigation.
