Matt was elected as a Fellow of the American College of Trial Lawyers in 2004 and has been recognized as an Illinois Super Lawyer each year since 2005. In 2017, the Illinois Supreme Court appointed Matt to serve on the Court's Committee on Jury Instructions – Civil, where he continues to serve.
